
Working with the Government of Ghana, we have identified savings of over **USD\$1.3 billion** through value-for-money assessments on contracts for schools, hospitals and colleges

1. Pre-Contract Value-For-Money (VfM) Assessments

the client. By assessing contract forms and terms,

## 2. Contract Progress Audits

#### 3. Parallel Bid Evaluations


