#### CASE STUDY

### TRAINING THE KENYA ROADS BOARD ON BOND AND INFRASTRUCTURE FINANCE



Many organisations continue to face notable challenges when seeking to optimally allocate finite resources and maximise economic and social returns on capital investments.

To facilitate this, modern investment programmes need to take account of environmental, social, and governance (ESG) risks and opportunities, and more broadly contribute towards the Sustainable Development Goals (SDGs). In March 2022, Kenya Roads Board (KRB) engaged Crown Agents to deliver a highly contextualised training course in Dubai for ten members of the Board of Directors. #### **CASE STUDY**

### FUNDAMENTALS OF PROJECT MANAGEMENT TRAINING WITH BANGLADESH BANK

Well trained project and programme management practitioners are essential for the successful delivery of strategic outcomes, however, as professionals from a range of disciplines become increasingly involved in projects, all managers now need a good understanding of the principles of sound project management.

In June 2021, Bangladesh Bank (The Central Bank of Bangladesh) contracted Crown Agents to develop a customised training course tailored to the needs of 11 officials within the bank's Project Management Unit (PMU) and related government ministries.

Bangladesh Bank was in the process of implementing a project entitled "Program to support Safety Retrofits and Environmental Upgrades in the Bangladeshi Ready-Made Garments Sector (SREUP)", in partnership with various Europe-based agencies. The training course delivered by Crown Agents aimed to equip delegates with key skills in project management so that they could meet the demands of this programme; this included facilitating low-cost finances to the export-oriented RMG factories of Bangladesh to address their safety remediation and social and environmental up-gradation issues.
